Course Description

This course considers the role and nature of media and cultural industries, focusing on the production and circulation of popular culture and information. Industries examined include television, news, advertising, music, and networked technologies.

Objectives of the Course

By the end of this course, students should be able to:

- demonstrate familiarity with various media and cultural industries
- explain how these industries are changing with newer networked technologies
- critique the way that these industries intersect with social inequalities
- work effectively individually and cooperatively in groups, and hand work in on time

- develop presentation, research, and writing skills

20%	<p>Reading Quizzes</p> <p>Every Monday, students will complete a timed quiz (20 minutes) on D2L that covers the content from that week's required reading(s). Each quiz has 10 multiple choice and true/false questions. Students have a 24-hour window to complete the quiz and can consult with other students. There are 10 quizzes in total, worth 2% each.</p>	Weekly on Mondays
10%	<p>Media Diary</p> <p>Students will complete a worksheet that details their media consumption over the course of 3 days.</p>	Sept. 30
20%	<p>Company profile</p> <p>In pairs, students will choose and profile a Canadian media company from any industry. The profile should address company/industry history, essential technology, key roles, recent news, and future outlook. The profile will be presented to the class either in the form of a recorded presentation (using YuJa or similar software) or an infographic (using Piktochart or similar), which will be posted to D2L.</p>	Oct. 14
20%	<p>TV Questionnaire</p> <p>Students will choose a television program that originates from more than one country and trace how it circulates globally. Based on the required reading by Terra Sinic, the assignment will be submitted in the form of a questionnaire that addresses specific elements of transnational production and circulation.</p>	Nov. 4
30%	<p>Take-home exam</p> <p>Students will receive exam questions on Monday, December 7 and will have one week to compose answers to 3 essay-style questions. There will be a choice of questions.</p>	Dec. 14

Plagiarism

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possibly suspension or expulsion from the university. These requirements apply to all assignments and sources, including those in non-traditional formats such as Web pages or visual media.

You must document not only direct quotations but also paraphrases and ideas where they appear in your text. A reference list at the end is insufficient by itself. **In-text citations must be provided, and readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin.** Wording taken directly from a source must be enclosed within quotation marks (or, for long quotations, presented in the format prescribed by the documentation style you are using). Paraphrased information must not follow the original wording and sentence structure with only slight word substitutions here and there.
